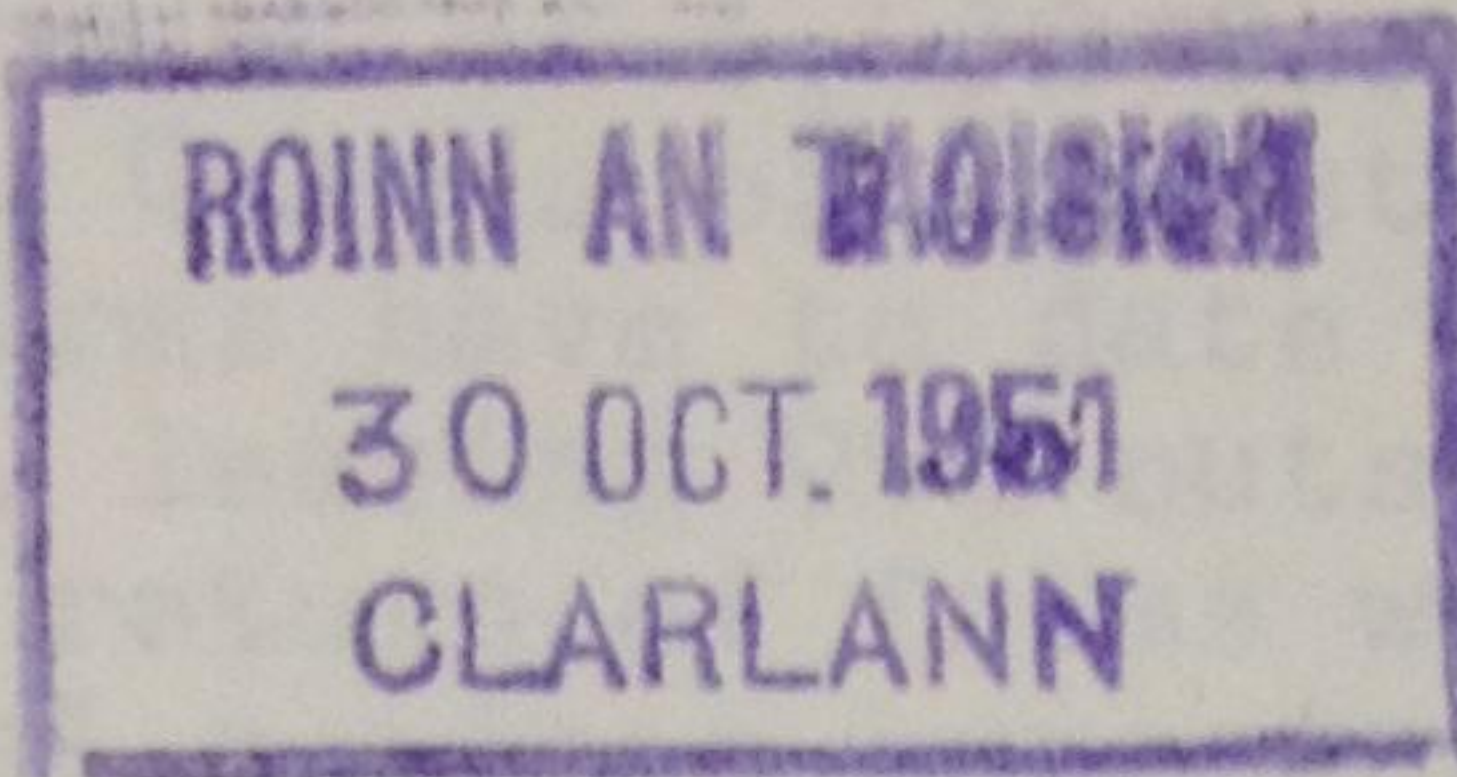

I have to request the approval of the Taoiseach to prosecute six of the most flagrant offenders among the 1,670 firms - approximately 6,000 firms are included in the Inquiry - who have not to date rendered the statutory return for the Census of Industrial Production, 1950. Reminders and "Final Notices" have been sent to all defaulters. The following are the six firms selected, not only by reference to the present inquiry, but also having regard to their records at previous inquiries:-

It will be noted that three of the firms are located in Dublin and three elsewhere.

A similar procedure was adopted on the occasion of the 1948 Census when summonses were issued against three defendants in Dublin and fines were inflicted in the District Court in all three cases. These convictions were well publicised and had the effect of stimulating a large part of the other defaulters to send in their returns. Furthermore at the time of the prosecutions arrangements are made with the Chief State Solicitor to issue "Solicitor's letters" to the more important of the defaulters.

Director,

A total of 6,032 forms were issued in connection with the Census of Industrial Production, 1948. 5,036 firms have to date furnished the statutory returns, leaving 996 outstanding. The statutory date for the return of forms was 31st May, 1949. Reminders and final notices have issued to the 996 defaulters without effect.

The outstanding returns are holding up the completion of the 1948 Census, the results of which are so urgently required in connection with the National Income inquiry. The final notice contains a threat of institution of proceedings, but this would appear to be now ineffective. I have discussed the matter with Mr. Lysaght, Assistant Chief State Solicitor, and he advises prosecution against a small number of firms. From the point of view of obtaining exemplary penalties he considers this preferable to listing a large number of firms.

Three Dublin firms have accordingly been selected for prosecution, viz.

- South of Ireland Asphalt Co. Ltd., 7-8 Lr. Abbey St.
- Dublin Bespoke Clothing Co. Ltd., 22 Wellington Quay.
- Knight & Petch (Dublin) Ltd., Drury Street.

The South of Ireland Asphalt Co. Ltd. have not furnished returns for the years 1946 and 1947 in addition to 1948; Dublin Bespoke Clothing Co. Ltd. similarly failed to furnish a return for 1947, and in the case of Knight and Petch the 1947 returns were only furnished seventeen months after the statutory date and then only as a result of three reminders and numerous phone calls.

It is proposed to seek the fullest possible publicity to the proceedings. The Chief State Solicitor's Office are prepared to sign and issue 150 "solicitor's letters" prepared in this Office which it is proposed to issue simultaneously to 150 other principal firms from which returns are essential to complete the Census.

Please see foregoing minute. I would be glad to have approval to prosecute the three firms named - relevant files are appended. It is some years since Census of Industrial Production defaulters were prosecuted. The prosecutions are carefully timed to coincide with the issue of the 150 "solicitors' letters" - a new expedient. We hope to get publicity for the prosecutions, though the firms will be small and the District Justice's observations may not be helpful.
